PROGRAM OUTLINE

This program offers an in-depth exploration of child health, safety, and nutrition. Students will develop and uphold policies that ensure children's well-being and safety. They will learn to implement universal precautions, hygiene practices, and procedures. The program also covers planning, preparing, and serving meals and snacks that fulfill children's nutritional needs. Focusing on prevention, students will study strategies for assessing, managing, and reporting illnesses. Additionally, child protection duties and licensing regulations will be addressed. Theoretical principles of health, safety, and nutrition will be taught, allowing students to integrate them into the early childhood curriculum.

 - a. Equal to or before 10% of the hours of instruction to be provided during the contract term have been provided, the institution may retain up to 30%of the tuition due under the student enrolment contract.
 - b. After 10% but before 30% of the hours of instruction to be provided during the contract term has been provided, the institution may retain up to50% of the tuition due under the student enrolment contract.
 - c. After 30% of the hours of instruction to be provided during the contract term have been provided, the institution may retain 100% of the tuition due under the student enrolment contract.
